## CWREC Data Analysis & Mapping Report 2023

## Co-Creating Shared Data

Over the last year, several collective efforts were executed to launch the newly published Child Welfare Race Equity Collaborative (CWREC) Data Analysis & Mapping Report. The CWREC Planning Committee teamed up with Partners, and the Strategy Committee which consists of majority BIPOC Grassroots Community Organizations and People impacted by the Child Welfare System to co-design the **CWREC Executive Summary. The CWREC** Data Committee along with our partners at the United Way co-created the Data Analysis Mapping Report. On October 2, 2023, CWREC shared a 2023 PRESS RELEASE and results with the community. A report like this has not been done in several years, much less with a process to include the collective wisdom and experiences of an ecosystem of people in various roles. The Austin Monitor reported on the finding. You can read the article here.

These findings make it clear: we must continue daily efforts to promote equity and



support families in Travis County. We've analyzed the data, and now it's time for collective action. The Child Welfare Race Equity Collaborative is calling on our entire community, including government, businesses, nonprofits, faith-based groups, and individuals, to join hands.

# **CPS/CPI Policy**

#### **Policy Impacts Families**

The 2023 Legislative session was one for the books. In addition to banning DEI on college campuses and continuing the attack on transgender youth, the Texas Legislature passed key laws impacting persons involved or potentially involved in the child welfare system. While there were multiple pieces of legislation, we want to highlight three of them here.



This bill requires DFPS to notify parents of their rights at the onset of the investigation.

#### **HB 63 Anonymous Reporting**

This bill eliminates anonymous reporting of suspected child abuse and neglect.

### **SB 2120 Legal Representation**

This bill provides legal representation and services to parents who are impoverished and named in a suit filed by DFPS.
